HOTEL SUED FOR NEGLIGENCE AND SUFFERS ALMOST HALF A BILLION IN DAMAGES

Imagine working at Keekorok Lodge in Maasai Mara National Park in the year 2016. The dinner tables are set and the ambience is magical. You remember all your tutorials and classes at AIHT especially on service and everything is perfectly set. Your tutors will be so proud. You are thinking that all the years of hard work will one day eventually pay off. Your mind wanders to how the dinner setting is just vibes.

Before you think of your lover back in the city, your thoughts are interrupted by some commotion where one of the Chinese tourists at the hotel start arguing over sitting space. One is their tour guide and the other is the family Matriarch. Before you can respond to the situation that is now turning ugly the guide stabs the lady fatally.

You rush to call security and paramedics and when they arrive, they confirm your worst nightmare that the female tourist had died. Your many hours of learning had not prepared you for such eventuality. The events of this night forever remain etched in your mind and over the years you wonder what happened that night. Could there have been something to mitigate the turn of events?

Fast-forward 8 years later and you are now well established in your career. You have progressed very well and are earning some tidy sum from your hustle. Activities

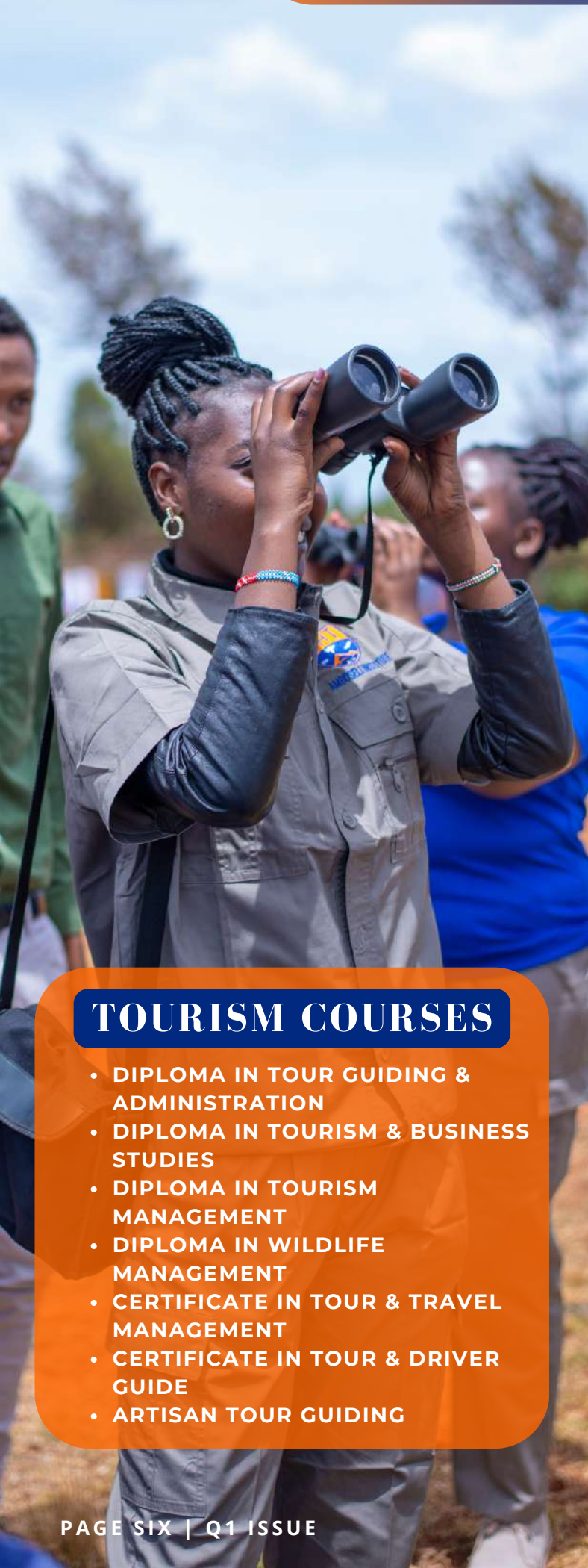
They got to enjoy activities such as ziplining, wildswing, canopy walk, team building & dance, plus much more.
